Module Wise New Changes

Family Enrollment – Member Addition

1. Firstly, resident need to add all your family members using their Aadhaar/Virtual ID and Birth Certificate (for children below 5 years).

2. You can link both Aadhaar and Birth Certificate together at the same time. But make sure the Name, Date of Birth, and Gender match exactly on both documents.

3. If a member was born in Rajasthan after January 1, 2018 and is older than 5 years, then both Aadhaar and Birth Certificate are required.

4. If the member is from outside Rajasthan, then Aadhaar eKYC is mandatory.

5. Once Aadhaar is verified, the member's Name, Date of Birth, Gender, and Photo will be fetched automatically and shown in the list.

6. If the member is a government employee, they can also link their Government ID themselves after the member appears in the list. Employee details with SIPF will be matched.

Family Enrollment – HoF Selection

- After successfully adding all family members, the next step is to select the Head of Family (HOF).
 Only members who meets the eligibility criteria will be displayed in the HOF selection list (e.g., age, gender)
- 2. Once user select the HOF, a popup window will appear where the user need to enter and link (seed) the HOF's mobile number and bank account number.

(Make sure the details are correct, as this information will be used for verification and benefit transfer purposes.) After entering the details, click Save to proceed.

3. Once the HOF details are saved, the Address section will appear.

Family Enrollment – Relations Linking

- 1. This is a separate tab where the user needs to enter their Father's Name, Mother's Name, Spouse's Name, and Marital Status.
- 2. The relations will be derived and displayed as per the standard relationship matrix, which will be available on the website for reference.
- 3. When the "Relationship with HOF" is selected:
 - If the selected relation is Spouse, the Spouse's name will be auto-derived based on the HOF's details.
 - Similarly, if the relation is Father or Mother, the system will automatically fetch and display the correct name accordingly.
- 4. Resident can also link Jan Aadhaar Id of the Father/Mother to create Family Tree

Family Enrollment - Preview

- 1. In Jan Aadhaar 2.0, a valuable additional feature has been introduced that allows users to review all the entered details before final submission.
 - This includes information such as personal details, family member details, relationship matrix, documents uploaded, and other seeded information like bank account, Aadhaar, etc.
 - By using this feature, the user can ensure accuracy and completeness of the entire application and make any corrections if needed.
- 2. To complete the application, the user must perform an E-sign. For this, the user can select any one of the available family members (18+) to sign the application.

Once the E-sign is successfully done, the system will generate and provide the Enrollment ID and Application Number.



Family Enrollment – Submission & Acknowledgement Receipt

- As soon as the user submits the application, a confirmation popup will appear displaying the message: "Your application has been saved successfully." Additionally, if the user wants a hard copy, they will have the option to print the receipt directly from the popup.
- 2. The receipt is designed to display all the submitted information clearly and in a well-structured format, ensuring that the user experience remains smooth and visually pleasant.
