Sub.: Constitution of DBT State Advisory Board

Whereas the DBT Mission, Cabinet Secretariat, Government of India has decided to fasttrack implementation of Direct Benefit Transfer (DBT) as a major reform initiative to ensure better and timely delivery of benefits from Government to the people.

With a view to smooth implementation of DBT mission in the State and as required by Gol, the State Government is pleased to constitute a Direct Benefit Transfer (DBT) State Advisory Board for proper implementation of Direct Benefit Transfer (DBT) framework across the schemes in the State which will be the real interface between the Government and the beneficiaries.

The Terms of Reference (ToR) of the DBT Advisory Board will be as follows:-

- State DBT Advisory Board will consolidate and sift the guidelines received and direct them to the respective State Department with unity of command for implementation of DBT in various schemes of State Govt. providing, Technical, Implementation and Coordination support in coordination with DBT Mission, Govt. of India.

- ii) Provide, Technical, Implementation and Coordination support to the DBT Cell of each Departments of State Govt.
- iii) Ensure the process of delivering the benefits on the DBT platform in time bound manner.
- iv) Monitor and evaluate the transition to DBT by the respective Departments as per the target fixed by Govt. of India
- v) Enable beneficiary-centric policies and innovative methods for developing userfriendly techniques.
- vi) Liaison with all stakeholders for transition to DBT effectively.
- vii) The advisory Board shall meet once in a quarter or in any other regular intervals, as deemed appropriate.
