File No. F 12(8)Agri-1/Input/2022 .-Whereas, the use of Aadhaar or Jan-Aadhaar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one's identity;

And whereas, the Department of Horticulture, Government of Rajasthan is administering the Program of Fertigation, Foliar Fertilization and Automation, hereinafter referred to as the program, under the Program, non-cash benefits, hereinafter referred to as the benefits, are given by the Department of Horticulture as per the eligibility of the beneficiaries as per the extent of Program guidelines;

And whereas, the aforesaid program, integrated /to be integrated with Jan Aadhaar platform, involves recurring expenditure incurred from the Consolidated Fund of the State of Rajasthan;

Now, therefore, in exercise of the powers conferred by section 3, 4 and 14 of the Rajasthan Jan-Aadhaar Authority Act, 2020 (Act No. 3 of 2020), the State Government hereby notifies the following, namely: -

1. (I) An individual eligible for receiving the benefits under the program shall hereby be required to furnish proof of possession of the Jan- Aadhaar number or undergo Jan-Aadhaar authentication.
- (II) Any individual desirous of availing benefits under the program, who does not possess the Jan-Aadhaar number or, has not yet enrolled for Jan-Aadhaar, shall be required to make application for Jan-Aadhaar enrollment before registering for the program provided that he/she is entitled to obtain Jan-Aadhaar as per section 6 of the said Act, and such individuals shall visit any e-Mitra or JANAADHAR Website www.janaadhar.rajasthan.gov.in to get enrolled for Jan-Aadhaar:

Provided that till the time Jan-Aadhaar is assigned to the individual, benefits under the program shall be given to such individual, subject to the production of the following documents, namely: -

- (A) If he/she has enrolled, his/her Jan-Aadhaar Enrolment Identification slip; and
- (B) Any one of the following documents, namely: -
 - (i) Bank or Post office Passbook with Photo; or
 - (ii) Permanent Account Number (PAN) Card; or
 - (iii) Passport; or
 - (iv) Ration Card; or
 - (v) Voter Identity Card; or
 - (vi) MGNREGA card; or
 - (vii) Kisan Photo passbook; or

- (viii) Driving license issued by the Licensing Authority under the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988); or
- (ix) Certificate of identity having photo of such person issued by Gazetted Officer or a Tehsildar on an official letter head; or
- (x) Any other document as specified by the Department.

Provided further that the above documents may be checked by an officer specifically designated by the Department for that purpose.

2. In order to provide benefits to the beneficiaries under the program conveniently, the Department shall make all the required arrangements to ensure that wide publicity through the media shall be given to the beneficiaries to make them aware of the said requirement.
3. In all cases, where Jan-Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely:-
 - (i) In case the biometric authentication through fingerprints is not successful, whenever feasible and admissible authentication by Jan-Aadhaar One Time Password.
 - (ii) In all other cases where biometric or Aadhaar or Jan-Aadhaar One Time Password authentication is not possible, benefits under the program may be given on the basis of physical Aadhaar or Jan-Aadhaar card whose authenticity can be verified through the Quick Response code printed on the Aadhaar/Jan-Aadhaar Card.
4. This notification shall come into effect from the date of its publication in the Official Gazette.
